Deposit, Terms of Payment & Refunds (All Amounts are in Canadian Funds)

Full payment of the application is due within 90 days of application. If you are taking advantage of a discounted rate, full payment is due by the deadline date for the special.

Refunds are available if, for whatever reason, you cannot attend the event. However, the amount of your refund is dependant on when you withdraw. A cancellation fee of \$350 will be incurred if you withdraw from the event more than six (6) months from the start. If you withdraw between six (6) months and two (2) months from the start of the event the cancellation fee is \$700. Withdrawal from the event within two (2) months of the event will incur a cancellation fee equal to 50% of the entry fee paid by the entrant. If you fail to appear at the event without notifying the event you forfeit your entry fee in full.
